### **BLENDED LEARNING UPDATE**

The apprenticeship school year has ended and this is a good time to report on the Blended Learning System. As you may recall, our first year Inside students began the year using this system which has them doing their homework on-line prior to attending the classroom for face to face instruction.

Aside from one student who had a technical problem, the system worked extremely well. At least there's been few complaints voiced at the JATC meetings. In fact, at one JATC the instructors have taken advantage of having a detailed report of the students' homework to provide the committee when a student fails a test. The report they receive is so detailed that

it indicates the amount of time spent doing the homework, when it was done, how well the student answered the questions and whether they went back to review the questions they got wrong. Not surprisingly the test scores mirror the amount of preparation. Usually when confronted with this documented information the student has an epiphany.

The ETA has done a great job with the roll out of this new system. Thanks to the JATC programs who participated in the beta testing last year and all the information that was gathered then disseminated, this has turned out to be a "textbook" roll out.
